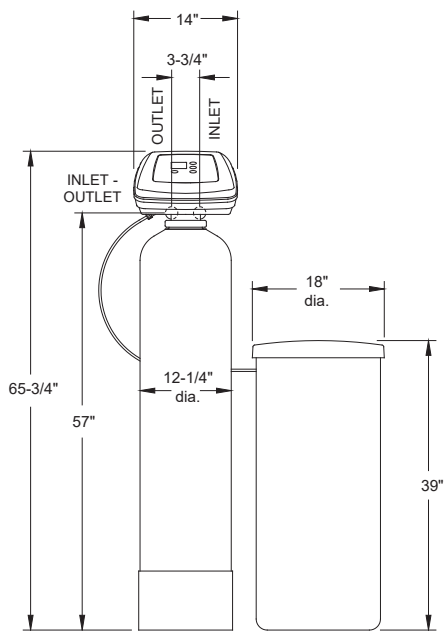

If, during such respective period, a part proves to be defective, Warrantor will ship a replacement part directly to your home, without charge.
